## Overview:

This SQA approved Training Programme has been designed for qualified electricians looking to update their BS 7671 training. This course is suitable for electricians who are responsible for ensuring that electrical installations are installed and commissioned in accordance with current requirements. **This course is also suitable for Applicants applying for ECS gold cards only.**

Note: The course does not cover the detailed requirements for inspection and testing of new or existing installations.

## Introduction to BS 7671

Modules 1-8 provide a basic introduction to BS 7671. The aim of this part of the course is to ensure that delegates can successfully navigate and find key information from the IET Wiring Regulations (BS 7671). It is estimated that this introductory section of the course will take approximately four and a half hours to complete and can be completed in stages.

This part complements the material that will be covered in modules 9-12.

## Requirements for Electrical Installations to BS 7671:2018+A2:2022

Modules 9-12 covers in detail:

### Module 9

- Scope, Object and Fundamental Principles
- Definitions
- Assessment of General Characteristics

### Module 10

- Protection for Safety

### Module 11

- Selection and Erection of Equipment

### Module 12

- Inspection and Testing
- Special Installations or Locations
- Functional Requirements

It is estimated that modules 9-12 of this course will take approximately eight hours to complete and can be completed in stages.

There are multiple-choice assessments at the end of each module. You are required to successfully pass each module before the next one will unlock. During modules 9-12 if you are unsuccessful in passing, the course will take you back to revise on the sections that you have failed on.

**Note:** You will have two attempts to successfully pass each module.

**This course must be completed within one month from the date of booking.**
